

FileRun – License Agreement

Last update: September 19, 2016

Introduction

This is a license agreement (“Agreement”) between Afian AB and you or the organization on whose behalf you are entering this agreement (“You”), in which Afian AB grants you certain rights to use the software program FileRun (“Software”).

Afian AB is allowed at its sole discretion to assign the Agreement or any rights hereunder to any third party, without giving prior notice.

The Agreement shall be governed by and interpreted in accordance with the laws of Sweden, without reference to its conflict of law principles, and shall be subject to the jurisdiction of the courts of Sweden.

By downloading, installing, copying or otherwise using the Software, you accept the following terms and conditions. If you do not agree with any of the terms or conditions of this Agreement, do not proceed with the downloading, copying, installation or any other use of the Software or any portion thereof as you have no rights to do so.

This Agreement does not apply to any Software license sold by Afian AB.
This Agreement applies only to Software provided at no cost on a date later than September 1st 2016.

Copyright

The Software, its source code and files are original works exclusively owned by Afian AB and subject to copyright laws and international copyright treaties, as well as other intellectual property laws and treaties.

Any and all intellectual property rights in the Software, including the original works, or parts thereof, in any form, are and shall remain the exclusive property of Afian AB. Nothing in this Agreement intends to transfer any such intellectual property rights to You. You will not take any action to jeopardize, limit or interfere with Afian AB's rights.

You must not remove, obscure or interfere with any copyright, acknowledgment, attribution, trademark, warning or disclaimer statement

affixed to, incorporated in or otherwise applied in connection with the Software.

License Limitations

Subject to the terms of this Agreement, Afian AB hereby grants You a limited, personal, non-exclusive, non-sublicensable, non-assignable license to download, install and use one single copy of the Software.

You may not sublicense, sell, assign, pledge, re-sell, rent, hire, lease, lend, transfer, distribute or otherwise dispose of the Software or portions of it, in any form, on a temporary or permanent basis, without the prior written consent of Afian AB.

You are explicitly not permitted to redistribute the Software to any third party. Keeping reasonable copies of the Software is permitted solely for onsite or offsite back-up purposes.

Without the express permission of Afian AB, the Software may under no circumstances be embedded inside another product, nor branded as another product, whether distributed or not.

You are not permitted to reverse engineer, disassemble, decompile or make any attempt to discover the source code of the Software.

Any analysis of the Software, embedded data or license files by any means and by any entity whether human or otherwise and including but without limitation to discover details of internal operation, to reverse engineer, to de-compile object code, or to modify for the purposes of modifying behavior is forbidden.

A user account refers to a unique "login name" that a person can use to access the Software's functions. You are not allowed to have at any given time more than three (3) user accounts in one Software installation.

Afian AB may, but is not obligated to, provide you with updates or upgrades to the Software for free or subject to the payment of additional service fees. By installing, copying or otherwise using such update or upgrade, you agree to be bound by the terms of this Agreement with respect to such update or upgrade.

Limitations of Liability

Data Privacy

You retains full ownership to the data managed with the use of the Software. This Agreement does not grant Afian AB any rights to your data or intellectual property. Afian AB will not share your data with others, including law enforcement, for any purpose, unless You direct Afian AB to do so. The Software provides features that allows You to share data with others or to make it public. You should consider carefully what you choose to share or make public. Afian AB has no responsibility for what other people might do with your data. You are the solely responsible for your conduct, the content of your files and folders, and the communications with others while using the Software. You, and not Afian AB, are responsible for maintaining and protecting all of your data.

Termination of License

Any violation against this license or its intended meaning will result in the immediate termination of this license and all rights given to You. You shall stop using the Software, remove the Software installation from your computer and server, and permanently erase all copies you made of the Software.
